Rules and Regulations

1. All teams will consist of two people: one Judge and one Sheriff. All teams **MUST** have a team sponsor. Sponsors can be non-profits, churches, clubs, organizations or local businesses.
2. A "Ransom" fee of \$20 will be collected from each team. These entry fees will be collected and then distributed to the 1st and 2nd place teams at the conclusion of the competition. First place will be awarded 60% of the total collected Ransom and second place will receive 40%.
3. Winners are determined by the number of buttons sold and/or monies collected. All buttons will be sold for \$1.00 each. Sales will begin September 16, 2016 5:30PM-7:30PM at the Pioneer Days Kick Off to be held at the Bowladium, 73768 Gorgonio Dr, Twentynine Palms, CA 92277.
4. At the Pioneer Days Kick Off, each team will be given 100 buttons. Additional buttons can be picked up from the Chamber of Commerce office. In order to receive additional buttons, button sales monies must be deposited with Chamber of Commerce personnel. Candidates should retain receipts of deposit as proof of buttons sold.
5. The contest will end at 4:00PM on October 20, 2015. All money collected and any unsold buttons need to be returned to the Chamber of Commerce by that time. Winners will be notified and announced publicly on Friday October 21, 2015 by the contest coordinator and Chamber of Commerce officials.
6. In the event of a tie, the top two teams will be given any remaining buttons and will have 24 hours for a sudden-death duel! The team that sells the most buttons after the duel will be awarded the applicable "ransom" and dubbed Pioneer Days Judge and Sheriff.
7. The official Pioneer Days Judge and Sheriff are encouraged to ride in the annual Parade on Saturday, October 22, 2016 at 10:00am.
