How to Enter:

- Entries will be accepted from October 21- October 24, 2016.
- Entries will only be accepted via:
 - Instagram-- Those wishing to have their photos entered into the contest must post an image using the hashtags #29Pioneerdays2016 and #pioneeringwoman in conjunction to enter. Posts should also tag the Twentynine Palms Chamber of Commerce account (@29chamber) and include a brief caption describing how the image illustrates the contest theme.
 - Email—Photographs may be emailed to 29chamber@29chamber.org. Please include description.

Contest Rules:

- The contest is open to all. Entrants under 18 years of age require the permission of a parent or guardian. By entering the contest, entrants under 18 years of age indicate that they have obtained the permission of a parent or guardian.
- Photos must be the original work of the entrant. By submitting, the entrant agrees that they are the sole copyright owner of the image.
- Photos must be taken during the Pioneer Days, October 21-23rd.
- Entries will be accepted from October 21- October 24, 2016. The judging period will take place from October 30 – November 17, 2016 and will be judged by our Board of Directors and members of the PAAC (Public Art Advisory Committee). Contest winners will be announced on our facebook page November 18, 2016.
- Participants may enter as many images as they wish. To enter, post entries to Instagram using the hashtags: #29Pioneerdays2016 and #pioneeringwoman. **These two hashtags used in combination constitute entry into the contest.** Or submissions may be emailed to 29chamber@29chamber.org
- Images containing illegal or prohibited activities will be disqualified.
- Members of the Chamber Social Media Team will narrow entries to a top ten. A panel comprised of Chamber board members will select the winning image.
- Prize: the winning image will be featured in the Twentynine Palms Visitor Center and Chamber of Commerce office. Top 10 images will be featured on Chamber and Visitor Center social media accounts and newsletter.
- By submitting an entry, the entrant (in case of minors, the minor's parent/legal guardian) grants the Twentynine Palms Chamber of Commerce, or its authorized representatives and contractors, the right to reproduce, prepare derivative works of, distribute or display and use these materials in whole or in part, for government and non-government purposes, in any manner or media (whether now existing or created in the future), in perpetuity, and in all languages throughout the world.
